Topic : Implication of the Energy Crisis in Europe in light of the Russian invasion in Ukraine

The European Union Commission,

Noting with deep concern the severe energy crisis exacerbated by the Russian invasion of
Ukraine,

Alarmed by the extreme supply insecurity across Europe,

Taking into consideration the struggles of Member States dependent on Russian energy,

Keeping in mind that consuming Russian energy implicates indirectly funding the Russian
aggression towards Ukraine,

Emphasizing the importance of Member-State cooperation to combat the challenges imposed
by this crisis,

Deeply conscious that the new future of Europe relies on sustainable energy alternatives,

Whereas:

- 1) In order to strengthen the RepowerEU funds, all Member States will contribute according to their GDP.
- 2) A new Unified Energy Network (UEN) shall be implemented in order to effectively share energy.
- 3) Through the RepowerEU funds investments in renewable energy are vital for ensuring energetic independence.

HAVE ADOPTED THESE REGULATIONS:

Article 1 : Strengthening the REpower EU funds

1. Endorses the strengthening of REpower EU funds, NGO funds and the UN World Bank where all member states contribute according to their GDP with the objective to:
 - a) build energy-related infrastructure;
 - b) assist countries highly dependent on Russian energy in reducing their reliance;

Article 2 : The Unified Energy Network

1. Establishes the creation of a new Unified Energy Network with the utilization of RepowerEU energy funds with the aim to:
 - a) share energy resources across EU member states;
 - b) diminish dependency on foreign countries;

Article 3 : Renewable Energy sharing energy sources across EU member states;

1. Emphasizes the importance of investing in renewable energy strengthening and development such as:
 - a) geothermal energy;
 - b) off-shore wind energy;
 - c) solar energy;
 - d) hydro-electric energy;

Article 4: Countries division of groups

4. Commands the formation of several collaborational sectors composed by Member States;

- a) Iberian group;
- b) Central group;
- c) Nordic-Baltic group;
- d) Mediterranean group;
- e) Balkans group;
- f) Visegrad group.

Article 5: **Liquified Natural Gases (LNG)**

1. Recommends short-term utilization of LNG imports from reliable foreign exporters such as:
 - a) The United States;
 - b) Australia;
 - c) Qatar;
2. Encourages the sharing of this energy surplus across the EU using the UEN

infrastructure.

Article 6: **Strengthening Energy Stock**

1. Recommends the strengthening of energy stocks to ensure security and stability.

Article 7: **Awareness Campaigns**

1. Promotes the implementation of EU-enlaces public awareness campaigns targeting both citizens and corporations through means such as:
 - a) media campaigns, (social media,tv,etc);
 - b) campaigns in schools;
 - c) creating a team of experts to raise awareness in cooperations about energy waste;
