

WHAT IS A CRISIS COMMITTEE?

Crisis committees are significantly different from the rest of the committees. **Unlike other committees, the crisis committee's topic is confidential until the first session.** This committee will have “crisis updates” which are real-time situations the delegates must resolve urgently through debate. Crisis committees are overall small committees, normally including around 24 delegates, making the debate have a faster pace and being more dynamic.

The purpose of the Ad-hoc Crisis Committee is to test the most capable delegates by presenting a topic on the same day of the conference and preventing them from doing in-depth research. The delegates must be informed about a wide range of historical and international affairs themes



in addition to being creative, impulsive, and self-assured enough to handle crisis circumstances with no background information. All attendees should be ready for a conference filled with dynamic crisis updates, situations that change quickly, and intense, fast-paced debate in one of the conference's strongest committees. Crisis committees are designed to test delegates by placing them into unfamiliar situations and forcing them to collaborate with peers in high-pressure situations to create detailed solutions to complex problems. The same and more is expected of delegates in the Ad-hoc Crisis committee.

Delegates do not conduct position papers in advance of the conference, but must deliver a country report including political, economic, cultural and historical aspects of the country in a two page document with the heading sampled in position paper documents on the website. Failure to submit this document to chairs will disqualify the delegate from any awards.
